The Board of Supervisors consists of three members elected at-large for staggered six-year terms. The Board is the Executive and Legislative branch of the Township's government that is responsible for establishing policy, adopting ordinances, regulating land use and overseeing the Township's finances. The Board holds a workshop meeting on the first Wednesday of the month at 7 p.m. The regular meeting is on the 2nd Wednesday of each month at 7 pm.

The Board also appoints residents to a variety of other boards, committees and commissions. Listed on page 4 are the most active groups and their meeting schedules. Please contact the Township Administration Office if you are interested in serving on one of these bodies.

#### Mission & Vision

Honey Brook Township was incorporated on February 24, 1789, from the western part of West Nantmeal Township. It is classified as a township of the second class, with a Board of three Supervisors elected at-large for six-year terms.

The following mission and vision statements were adopted in 2004:

The mission of the Board of Supervisors of Honey Brook Township shall be to provide municipal services related to land use, police protection and public works in order to maintain a community that supports a tranquil and rural way of life. The vision of the Board of Supervisors for the future of Honey Brook Township is that the Township shall remain a predominantly agricultural community that surrounds a population hub offering various commercial and social activities. The vision includes the establishment of a land preservation program, concentration of non-agricultural uses along specific portions of major arterials, betterment of current low-income housing areas, upgrading of all governmental and quasi-governmental facilities, reduction of non-local traffic in congested areas, and exploration of Township and Borough integration.



## **General Information**

Township Population (2010 census): 7,647 Land Area: 25.4 square miles

State Roads: 24 miles

Township Roads: 52.64 miles

**Township Taxes** - The Township collects two types of taxes each year. Earned Income Tax, based upon wages, and a real estate tax based upon a property's assessed valuation.

**Earned Income Tax** - Keystone Collections Group collects 1% on behalf of the Township and 0.5% on behalf of the Twin Valley School District. The Township portion is used for general operation costs and for land preservation. Like your state and federal income taxes, you must file with Keystone by April 15th each year. Forms are available by contacting Keystone Collections Group 610-269-4402. Call 1-866-539-1100 or visit Keystone's website at https://www.keystonecollects.com/ to file electronically.

**Real Estate Tax\*** - Residents in Honey Brook Township pay three types of real estate taxes to two agencies.

- 1. **Twin Valley School District** The School District collects its own real estate tax. The 2018-2019 tax rate is 29.4248 mills for Chester County. The 2019-20 rate is yet to be announced\*\* Contact the district's tax office at 610-286-8632 for more information.
- 2. **Chester County** Chester County collects its own real estate tax (Chester County Treasurer: 610-344-6370). The 2019 tax rate is 4.369 mills. Contact the County Assessment office at 610-344-6105 for more information.
- 3. **Honey Brook Township** The Chester County Treasurer collects the Township's real estate tax. The 2019 tax rate is 0.98 mills. Visit the Treasurer's website at http://www.chesco.org/161/Treasurer or call 610-344-6105 for information regarding tax bills and tax certifications.

\*County and Township tax rates take effect January 1; School District tax rates take effect July 1.

\*\* School tax rate for 2019-20 is not final until the budget is submitted to the Pennsylvania Department of Education in June.

## **Appointed Officials and Staff**

**Township Manager/Secretary, Steve Landes:** Responsible for the day-to-day administration of Township business including finances, budgeting, staff, and provision of Township services.

**Public Works Director**, **Don Johnson:** As the head of the Roads Department he is responsible for the maintenance of the Township roads, storm sewers, street signs, and Township buildings and grounds including James A. Umble Memorial Park.

**Solicitor, Christopher Hartman, Esq.:** Provides the Board of Supervisors and Manager with legal opinions and guidance. Represents the Township in court proceedings.

**Solicitor to the Zoning Hearing Board, Kenneth Werner, Esq.:** Provides the Zoning Hearing Board with legal opinions and guidance.



## **Zoning Update**

The Updated Honey Brook Township Zoning Ordinance of 2018, also known as Chapter 27 in the Honey Brook Township Code of Ordinances, has been codified and is available online at https://ecode360.com/30832599.

A public hearing will be held at the Board of Supervisors Regular meeting on July 10, 2019, to consider enacting two ordinances:

- Ordinance 197-2019, adding & creating regulations of brew pubs, microbreweries, microdistilleries, and wineries; revising parking regulations regarding commercial vehicles; revising height regulations for non-commercial antennas & towers; revising regulations for commercial establishments in MUR; amending definition of kennels; revising language regarding permit issuance; adding wetland margin regulations; and minor revisions to inconsistencies
- Ordinance #199-2019: Zoning Map Amendments, changing classification of 24 parcels from Mixed Use Residential (MUR) to Mixed Use Commercial (MUC)

Drafts of these ordinances will not be available for public review until late June.

### **State Roads**

**GIRL SCOUT CADETTE, JAMIE FOX** - Jamie is working on her Girl Scout silver award and will work with the HB Community Library to refresh the back entryway's trash collection area and handicapped parking space, as well as installing a wall space for community handouts, freeing up space which is at a premium.



### **Trash Collection**

Residents are required to contract with their own trash hauler who will also provide recycling services. Residential developments managed by a Home Owners' Associations (HOA) may contract with a hauler for the entire HOA so please check with your HOA manager for this information. Burning of household trash, recyclables, and toxic materials of any kind is prohibited.

#### Yard Waste Recycling

All haulers collecting trash in Honey Brook Township must offer yard waste collection at least three times per year; once in the spring and twice in the fall. Please check with your hauler for their scheduled pickup date(s).

## **Recycling is Mandatory**

Pennsylvania and Honey Brook Township regulations require all residential, commercial, institutional, and municipal properties to separate recyclable materials from their waste and have it properly collected and processed.

Residential collection of recyclable materials shall be provided at least once each week by your contracted trash collector. Items to be recycled by all residential units including mobile home parks and apartments include Glass containers, Cans, Plastics No. 1 to No. 5 and No. 7, Paper (newspaper, books, catalogs, magazines, junk mail, paper, and envelopes), and Cardboard boxes and containers. Check with your collector to learn whether additional items may be recycled.

Residents shall also separate leaf waste from other recyclable materials and trash. Your trash collector is required to collect leaf waste at least once in the Spring and twice during the months of September through December. Check with your hauler for their schedule. You also have the option of disposing leaf waste by taking it to the Chester County Lanchester Landfill Composting Site.

Commercial, industrial, institutional, and municipal property owners / operators plus the sponsor of any community special event or other activity shall at a minimum separate all of the items required of residents listed above plus High-grade office paper and Corrugated cardboard.

These materials may be stored until collected. The property owner / operator shall annually provide written documentation to the Township of the types of materials and the total tons of materials that were recycled. This documentation is due no later than the end of January for the prior calendar year.



## How Does Our Garden Grow? With Help From You

Honey Brook Township and the Honey Brook Community Library are once again growing food in raised garden beds to benefit the community for distribution, through such organizations as the Honey Brook Food Pantry, Steeple to People, Shepherd's Kitchen, and the Salvation Army in Glenmoore.

The gardens grow food for three seasons of the year. This requires the seeds or plants to be planted, watered, weeded, and harvested. Currently, only a few people do this job at the Township building, and they need help. Please consider helping by giving one day a week of your time that works with your schedule! No need to come alone; bring the family!



The crops are usually simple--lettuce, spinach, beans, tomatoes, beets, carrots. The area isn't very large (80 square feet), and tending it takes anywhere from 15 minutes to an hour for weeding, watering, and sometimes debugging. No gardening knowledge is needed. It is an organic garden bed so no pesticide or insecticide is spread.

### **Pickleball Particulars**

We invite you to try pickleball at the James A. Umble Park tennis courts! Come by on Tuesday or Thursday evenings at 6:30 pm all summer long through September 19 (weather permitting) to learn more about the game and give it a try. No experience necessary! Nets and balls are provided along with a limited number of racquets available to borrow.

What is Pickleball? Pickleball is a racquet sport which combines elements of badminton, tennis, and table tennis. It is played with a perforated plastic ball (similar to a wiffle ball) and large paddles (similar to table tennis paddles) on a smaller, lined court that is one-half the size of a tennis court.

Why is it called Pickleball? The founders of the game had a dog, named



Pickles, who loved to chase the balls that went out of bounds. On occasion, he would not surrender the out-of-bounds ball, because it was "Pickles' Ball." The name stuck!

Who Plays Pickleball? The game was originally designed for seniors who could no longer play tennis, but it is an enjoyable challenge for all age groups.

## James A. Umble Memorial Park

Located at 173 Suplee Road, the park is open from dawn to dusk each day. A walking trail encircles the park and features a Born Learning Trail. Park amenities include three ballfields, two tot lots, picnic pavilion, tennis courts, and a sand volleyball court. A list of the park rules is posted near the entrance to the park.

Picnic Pavilion Reservations – Residents can reserve the pavilion for group outings free of charge on a first-come, first-served basis. The pavilion includes outdoor grills and picnic table seating as well as a hitching post and handicapped parking. Reserve the pavilion by submitting a Facilities Use Application together with a \$100.00 security deposit to the Township Administration Office. The security deposit will be returned provided that no damage occurs or clean-up is needed because of the group's use.



Park Equipment Available - Residents are allowed to borrow baseball/softball bases and pickleball equipment for use at the park. The equipment, which is located in the box located next to the front door of the Township Administration Building, is available on a first-come, first-serve basis. Please return the equipment promptly after your use.

## Dog Laws and Canvass Information

#### Pennsylvania's Dog Laws:

- If your dog (3 months of age or older) is not licensed, you may be fined up to \$300 per dog. Get a license at the Chester County Treasurer's office; at Bark Avenue, 3845 Horseshoe Pike, Honey Brook; or online at padoglicense.com. An annual license is \$8.50 and a lifetime license is \$51.50. If your dog is spayed or neutered, the annual fee is \$6.50 and lifetime is \$31.50. Discounts are available to older adults and people with disabilities. Remember, if your dog gets lost, a current license is the fastest way to get your dog back home. Licensing fees help protect the millions of dogs in Pennsylvania by funding the Bureau of Dog Law Enforcement.
- Dogs and cats three months or older must have a current rabies vaccination. Owners of non-vaccinated pets may be fined up to \$300, plus court costs. Have your dog or cat vaccinated by a licensed veterinarian, who can provide a vaccination certificate.
- Your dog must be under control and supervised at all times. You are responsible for any damages caused by your dog on someone else's property.
- It is illegal to mistreat or abuse animals. Report suspected abuse to the Brandywine SPCA at 610-692-6113 or to police.
- Purposely poisoning a dog, whether it is yours or someone else's, is illegal.
- You may not abandon or attempt to abandon any dog. You could be fined \$1,000, plus court costs.
- You may not keep a dog outside for more than 20 minutes in temperatures 32 degrees Fahrenheit or colder.
- Puppies under eight weeks old cannot be bartered, traded, sold or transferred.
- You must have a state kennel license if you keep, sell, transfer, adopt or foster 26 or more dogs in a calendar year.\*

 If your dog attacks or kills a human or domestic animal without provocation, it may be considered dangerous. You may face extensive fines and restrictions.

The Bureau of Dog Law Enforcement conducts a license canvass each year. Multiple wardens go door to door educating dog owners as well as checking the status of their dog licenses and rabies vaccinations. Violators may be fined.

\*Township zoning must be adhered to as well. See Section 27-1035 for more information on Kennel Use & Occupancy requirements.

Remember that the state issues kennel licenses, the Township's role is verifying the appropriate land use according to the Zoning

## Seven Ways to Be #StormwaterSmartPA

Here are actions you can take to reduce stormwater runoff pollution at your residence and in your community. You'll find more specific guidance on residential property stormwater best management practices in A Homeowner's Guide to Stormwater Best Management Practices, at http://files.dep.state.pa.us/Water/BPNPSM/StormwaterManagement/ConstructionStormwater/SW\_Booklet\_2017.pdf.

#### 1. Know the impaired streams near you

Visit the DEP's Pennsylvania stormwater GIS map site, http://www.depgis.state.pa.us/MS4/index.html. Select Chester County, then select Honey Brook Township, and then hit "click to view features." All the red lines are impaired streams. Click on the streams themselves to see their names and causes of impairment. Then take steps to start making a difference (see below).

#### 2. Plant a rain garden

Rain gardens are native plants set in a hole or trench in the ground to help rain water infiltrate into the ground. The Penn State Extension Office provides a great how-to on the basics of planting a rain garden, https://extension.psu.edu/rain-gardens-the-basics. The Honey Brook Township Park and Recreation Board organized the planting of a garden to help keep the stream next to the James A. Umble Park clean; check it out next time you're there!

#### 3. Set up a rain barrel at your residence

You can capture rainwater off your roof with a rain barrel, and then use the water in your garden or let it infiltrate slowly into the ground. There are various options, from very simple to more involved.

#### 4. Think about lawn care a little differently

Don't overwater your lawn. Consider using a soaker hose instead of a sprinkler. Use pesticides and fertilizers sparingly. Use organic mulch or safer pest control methods whenever possible. Compost or mulch yard waste; do not leave it in the street or sweep it into storm drains.

The Penn State Ag and Environment Center shares 10 tips to maintain your lawn and protect water quality from the Pennsylvania Landscape and Nursery Association:

#### 5. Contact your local government

Honey Brook Township is one of about 950 municipalities in Pennsylvania that are required to have stormwater management plans known as the Municipal Separate Storm Water System (also known as MS4), and is also required to have a Pollutant Reduction Plan. These plans are available for review at the Township Administration Office for review during normal business hours. Since MS4 municipalities are required to do public communications outreach to inform community residents about stormwater (through articles such as this one and other activities), the Township is always appreciative of anyone's help in organizing or publicizing a stormwater-related educational activity.

#### 6. Calculate the stormwater runoff on your property to make informed building decisions

The national Environmental Protection Agency (EPA) offers a stormwater calculator software tool at https://www.epa.gov/water-research/national-stormwater-calculator that will estimate runoff at a location based on information such as soil type, landscape and land-use information, and weather.

#### 7. Join forces!

Volunteer and professional organizations and businesses throughout Pennsylvania are taking action to reduce stormwater pollution. They offer classes on how to set up rain gardens and rain barrels at home. They hold events to plant rain gardens in city neighborhoods or vegetation on streambanks or to pick up trash. They work to find funding solutions for municipalities' stormwater efforts. And the list goes on.

## **Public Works**

#### **Roadmaster Reminders**

The Roadmaster has some reminders for Township residents for Spring and Summer travel:

- **Please heed** any barriers closing a road. Possible reasons for a barricaded road could include (but are not limited to) maintenance on the road rendering it impassable, flooding, downed live wires, or an accident scene.
- The Roads Department will be carving (or recarving) ditches along certain roadways to aid in drainage during rain events this year and during snowmelt next spring.
- Mowers will be out once grasses grow tall along the roadsides. These vehicles are slow-moving; please give them room to work. If you must pass, pass with caution; however....
- If road lines look especially bright or new, they are likely to be freshly-applied! Please keep in mind that the Township or Commonwealth is **not responsible** for any paint splatter on your vehicle that might arise from freshly-painted lines or vehicles applying paint to Township or State roads. Keep clear of paint spraying equipment and do not cross center lines or move between lanes if you suspect fresh, wet paint.
- Oiling and chipping of various roads will occur in the summer. This
  practice, while temporarily inconvenient, helps extend the life
  of road surfaces by diminishing the likelihood of potholes next
  spring. If signs have been placed that indicate fresh oil and chips,
  please slow down!
- Remember the Right-of-Way (ROW) Ordinance, as outlined in Chapter 21, Section 3 of the Township Code of Ordinances: anyone who installs shrubbery or other similar plantings and landscaping, fences, or similar improvements within the public ROW shall do so with the understanding that such items shall be removed from the public ROW when requested to do so by the Township.

## **Township Regulations**

## **Permits Required**

The Township requires that property owners obtain permits before starting most construction projects, opening a business, demolishing a structure or removing a trailer just to name a few. Listed below are common permits that are required:

 Building permits are required to erect, construct, reconstruct, enlarge, alter, move, change the use of, or demolish any structure which involves adding or removing structural square footage on the property. Permits are also required for sheds; decks, patios, and porches; signs; swimming pools and hot tubs; electrical/mechanical/plumbing; retaining walls; and new driveways and expansions.

Please note: Permits are not required for re-shingling of roofs; painting, flooring, or siding; exact replacement of windows or doors; sealcoating a driveway; or other cosmetic repairs, unless any structural changes or changes in footprint occur.

- Zoning permits are generally reserved for smaller projects that are not subject to the Uniform Construction Code; projects that are subject to the UCC require building permits.
- Other permits are also required including those for any new business including home occupations and businesses; change in use of any building; timber harvesting; trailer removal, and yard sales to name a few.

Permit applications can be found on the Township website under the Documents/ Forms tab, they can be picked up from the Township Office or the staff will be glad to mail them upon request. When in doubt, contact the Township staff with any questions.

## **Removing Trees in the Township**

If you want to remove trees on your property, you may need a permit issued by both the Township and the Chester County Conservation District. There are limits to the number of trees that can be removed or cleared from areas identified on the Township's Woodland Classification Map. In many cases the clearcutting of any woodland area is prohibited.

The removal of dead trees or the cutting of trees as part of a Christmas tree farming operation shall not be considered timber harvesting operations.

If you remove tress without a permit in an area governed by Township or County regulations you will likely have to hire a forester to prepare a replacement plan and then replace the trees as required by the Township.

Because of the technical nature of this regulation it is best if you contact the Township office to learn whether you need a permit. More information about timber harvesting requirements can be found in the Zoning Code on the Township's website.



Mid-Year 2019 Pantry News from the Board Chairman

Approaching the middle of our 6th year of serving local residents of the Honey Brook community, the HBFP has now registered nearly 1,300 families, serving over 10,000 pounds of food to 700-800 people per month. About one third of the families who no longer attend have been verified as "food independent", clearly validating our mission and providing tangible evidence of meeting the needs of hungry families while they exist. The number of "emergency" situations continues to increase and we have developed several solutions including off- hours service, increasing home deliveries and the utilization of retail grocers.

It is important to note that recent communication from regional distributors of public food have warned of decreased menu selection, especially regarding produce.....the number one item in popularity from our recent participant survey. Equally concerning has been the drop in retail donations as local grocers focus more attention on reducing excess product.

In our quest to drive independence, many exciting things are happening every week:

- The weekend **Kids' Back Pack Program (80)** through the two Elementary Schools is wrapping up with the highest ratings ever. **Summer food boxes will also be provided to all participating children**
- In conjunction with United Way of Chester County and Legal Aid, we have doubled our goal to **400 family real estate tax appeals** through July, projecting \$725 in savings/family/year or over **\$250,000**
- Healthy cooking demonstrations and ingredients are part of every distribution and our "Taste It" team has been invited to serve at this year's Brandywine Hospital Strawberry Festival (2-4pm on June 2nd)
- A **Registered Dietician and Health Educator** provides comprehensive testing, smoking cessation, referrals for low cost medical/dental services and wellness counseling at every distribution
- The "Garden for Life" program is expanding to over 50 families including 25 children and a Community Garden in the Borough Park is being added this year.
- Employment support services are now regularly available (25+ participating), including Career Link Services, job postings and on-site recruiting and **EIGHT PLACEMENTS** have already been made!
- The **Nutritional Supplement Program for Infant-Age 3**, when proper development is most critical for future health, has been a great success. Specialized foods, instructions, educational materials and counseling are offered to over 40 families and parental feedback is overwhelming

Despite tremendous support from the community, the resources of the pantry are challenged by great need. Because we operate in an area without a large business presence, your assistance helps improve the quality of the experience of those we serve.

## Pennsylvania Businesses Encouraged to Obtain a Spotted Lanternfly Permit

The Pennsylvania Department of Agriculture is encouraging businesses to obtain the required Spotted Lanternfly permit to ensure they are complying with the Spotted Lanternfly quarantine orders. Gearing up for the next phase of the Spotted Lanternfly life cycle, now is the best time for businesses to learn how they can jump-start this spring's fight.



There is no cost to businesses to obtain a per-

mit. Under the law, businesses in the commonwealth need to take the online permit training and exam and receive a permit for their vehicles. The Pennsylvania Department of Agriculture continues its work to contain and minimize the spread of the Spotted Lanternfly while also keeping commerce flowing in Pennsylvania.

Why is a permit needed? In November 2017, Thirteen Pennsylvania counties — Berks, Bucks, Carbon, Chester, Delaware, Lancaster, Lebanon, Lehigh, Monroe, Montgomery, Northampton, Philadelphia, and Schuylkill — were placed under quarantine to help stop the spread of the Spotted Lanternfly. States such as New York and New Jersey with Spotted Lanternfly populations are also required to follow the permit requirements for Pennsylvania. This will help prevent the movement of the pest from other states into Pennsylvania.

The Spotted Lanternfly permit training teaches business owners, managers, or designated employees how to comply with the quarantine – an important legal designation to help stop the spread of Spotted Lanternfly – to ensure each of their employees are complying with the law. The quarantine order directs businesses, residents and county authorities to follow guidelines to prevent the movement of the certain articles that contain any living stages of the Spotted Lanternfly, including egg masses, nymphs and adults

Starting May 1 of this year, the Department of Ag's Bureau of Plant Industry began performing inspections and verification checks to confirm that businesses are properly permitted. Failure to take the permit exam and educate employees could result in possible penalties and fines.

### **MS4 MATTERS**

## What is an "MS4" and where do MS4 regulations come from?

The federal Clean Water Act (CWA) prohibits the discharge of pollutants into United States' waterways without an associated permit. Pennsylvania and its Department of Environmental Protection (PaDEP) regulate the discharge of pollutants through multiple programs in order to meet the runoff related requirements set forth by the federal CWA. The MS4 program in particular regulates and permits discharges from municipal separate storm sewer systems (MS4). An MS4 is a system of stormwater conveyances (i.e. storm drains, pipes, ditches, and outfalls) that drain directly to waterways and are owned by a state, city, town, village, or other public entity.

Honey Brook Township has a regulated MS4; therefore, the township is required to develop and implement a stormwater management program which incorporates six minimum control measures to reduce contaminated stormwater runoff:

- Public education and outreach
- Public involvement and participation
- Illicit discharge detection and elimination
- Construction site runoff control
- Post-construction stormwater management in new development and redevelopment
- Pollution prevention and good housekeeping for municipal operations and maintenance

Untreated or uncontrolled stormwater runoff is the leading cause of impairment to our local waterways and the number one cause of water pollution throughout the United States. Stormwater runoff can pick up debris, chemicals, dirt (yes, excess dirt in our waterways is a pollutant) and other pollutants which then flow into a storm sewer system or directly into a lake, stream, river, wetland or coastal water, completely untreated. Pennsylvania's MS4 program is ultimately aimed at protecting water quality through pollution reduction at a municipal level.



## Be the solution to stormwater pollution!

Dirt, debris, garbage, and chemicals that run into our storm drains will flow (untreated) to our rivers. If you suspect an illicit discharge, contact Honey Brook Township at (610)-273-3970



## Food Safety During and After a Power Outage

Did you know the loss of power from high winds, snow, or ice could jeopardize the safety of your food? Knowing how to determine if food is safe and how to keep food safe will help minimize the potential loss of food and reduce the risk of foodborne illness. The following tips will help you make the right decisions for keeping your family safe during and after a power outage:

#### When the Power Goes Out . . .

Here are basic tips for keeping food safe:

- 1. Keep the **refrigerator** and **freezer doors closed** as much as possible to maintain the cold temperature.
  - The refrigerator will keep food cold for about 4 hours if it is unopened.
  - A **full freezer** will keep the temperature for approximately **48 hours** (24 hours if it is half full) if the door remains closed.
- 2. Buy **dry or block ice** to keep the refrigerator as cold as possible if the power is going to be out for a prolonged period of time. Fifty pounds of dry ice should keep an 18 cubic foot, fully stocked freezer cold for two days.
- 3. If you plan to eat refrigerated or frozen meat, poultry, fish, or eggs while they are still at safe temperatures, it is important that each item is **thoroughly cooked to a safe minimum internal temperature** to ensure that any foodborne bacteria that may be present are destroyed. However, if at any point the food was above 40° F for 2 hours or more (or 1 hour if temperatures are above 90° F) **discard it.**

#### Once Power is Restored . . .

Determine the safety of your food:

- 1. If an appliance thermometer was kept in the freezer, **check the temperature** when the power comes back on. If the freezer thermometer reads 40° F or below, the food is safe and may be refrozen.
- 2. If a thermometer has not been kept in the freezer, **check each package** of food to determine its safety. You can't rely on appearance or odor. If the food **still contains ice crystals** or is 40° F or below, it is safe to refreeze or cook.
- 3. Refrigerated food should be safe as long as the power was out for **no more than 4 hours** and the refrigerator door was kept shut. Discard any perishable food (such as meat, poultry, fish, eggs, or leftovers) that has been at temperatures above 40° F for 2 hours or more (or 1 hour if temperatures are above 90° F).

Perishable food such as meat, poultry, seafood, milk, and eggs that are not kept adequately refrigerated or frozen may cause illness if consumed, even when they are thoroughly cooked.
