Honey Brook Township is a Township of the second class with three residents elected at-large to make up the Board of Supervisors. Townships governed by elected boards of supervisors are the most common form of municipal government in Pennsylvania. The 1,454 townships of the second class in Pennsylvania represent a combined population of 5.5 million, 44 percent of the state total.

The Board of Supervisors is responsible for the Township's general governance, exercised by both legislative and executive functions. This includes setting policy, enacting ordinances, adopting budgets, levying taxes, and approving expenses. One Supervisor is elected at-large to office every odd-numbered year for a six-year term of office.

It is important to note that the authority and responsibility to perform these functions rests solely in the Board of Supervisors through the action of a majority of the Board voting at a legally advertised meeting that is open to the public.

Board Workshops

Board workshops are held the first Wednesday of the month at 7:00 pm, February-December, unless otherwise announced.

Board Regular Business Meetings

The regular business meetings are held the second Wednesday of each month at 7:00 pm except for January. The January meeting, which is also the Board’s reorganization meeting, is held the first Monday of January unless Monday is a legal holiday; then it is held on Tuesday. All meetings are open to the public and residents are provided the opportunity to speak.
